Chair Dunn called the meeting to order at 12:00 p.m.

They were asked to collect data and present it to the Board. The final decision is with the Board.

One was better with being comfortable with the panels, the other seemed nervous and the eye contact was not good, but then he warmed up and was more comfortable. One candidate is a better choice than the other, but that does not mean it is the right choice.

Chair Dunn thanked the technical and community panels for their part in the interviews of the two Fire Chief candidates.

At 1:00 p.m. Chair Dunn concluded this part of the open meeting and necessitated a 20-minute break.

**ACTION:** Riley motioned to not peruse either candidate; repost the Fire Chief Position with an increasing of the salary range. The motion was seconded by Strombeck and it passed unanimously (5-0).

### V. NFA TRAVEL COSTS: Stearns

Stearns informed the Board; CB Chapin has been accepted to attend National Fire Academy in Maryland. All expenses are paid, except the meals but travel expenses will be reimbursed to the individual. Our policy follows that; the individual pays for the flight and reimbursed by the Federal Government. He is unable to purchase the flight at this time. The question for the Board – Can we front him the money and when he is reimbursed, he pays it back? Board agreed that this was not a problem. This is a change from the policy. Stearns will inform him.
